
From the Desk of the Pastor

With the start of Lent being Ash Wednesday February 26th I thought it might be important to revisit why we do a few things for Lent. One of the most well-known parts of Lent is that it is a season of fasting. But what does it mean to fast during Lent? What does that really look like? How should we fast? Is the fast individual or corporate for the Church? These perhaps are questions you may not have thought of before, but on the other hand perhaps you have.

As we start Lent we put ashes on our fore-heads and hear the words remember that you are dust and to dust you shall return. These words remind us, each and every one of us, that we will die. In the Old Testament when people were enter-

ing into a time of fasting and repentance they would put on sackcloth and ashes. These ashes that will be placed on our foreheads show us that although we as individuals will now fast during Lent that we, as the corporate Church, enter into the season of fasting and repentance together.

During
the season of Lent the corporate body of Christ fasts
during the Divine Service.
This is the reason why we
don't sing or say our alleluias, the hymns of praise, and
why we veil the sign of victory, the cross, within the
sanctuaries. Fasting isn't just




about giving up soda, sweets,

desserts, or what have you, but is

truly about much more than that.

Do we mope around? Do we make a show of what we are doing? No! by no means should we do that. Instead as the Gospel text for Ash Wednesday tells us we should not show our individual fasts in public. There should be no one that knows that you are fasting during Lent. For the corporate reality it is harder to do this during the Divine Service. But we still in that reality don't mope around, we
